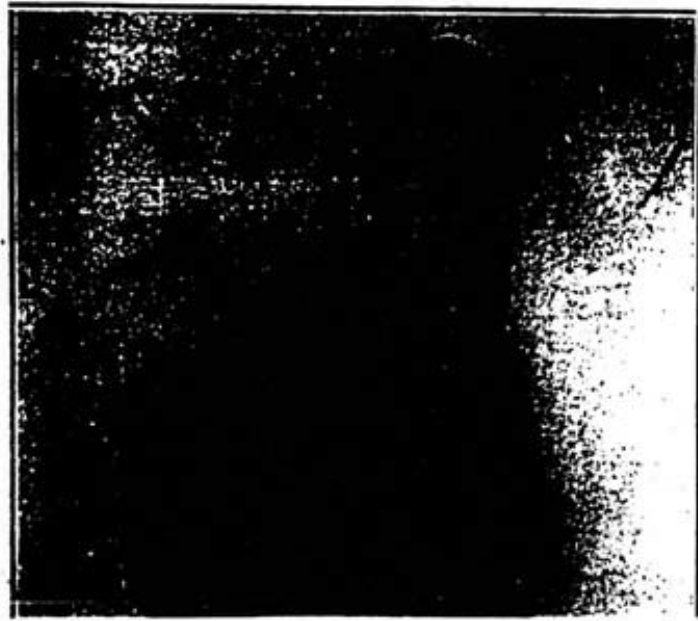

# Chester Aviator Shoots W. Phila. Girl Who Spurned His Advances

## Love-Mad Youth Trapped After Making Phone Call; Victim in Serious Condition

Maddened at the indifference of his unresponsive sweetheart, a Chester aviator beat her about the head with a revolver and sent three bullets tearing through her scalp last night before her home at 5813 Larchwood ave.

The youth, who later was captured by police, was identified as Frederick Hulton, 24, employed by the Essex Aviation Co., at Essington. He was held without bail for a further hearing by Magistrate Hamburger.

His victim, who is in a serious condition at the Misericordia hospital, was Miss Ann Lemanoff, 21, who told police during periods of consciousness of the ardent courtship that led up to the shooting.

She had met Hulton last summer while working as a magazine salesman, she said, and since he had refused persistently to heed her requests that he cease annoying her with proposals of marriage. Angered at his unrequited affection, he had threatened her several times before, and on one occasion, according to the girl's story, had accosted her in a machine as she walked along the parkway near the free library.

On that occasion, she declared, he became so incensed at her aloofness that he forced her bodily into the machine and speeded toward the outskirts of the city. For several hours she was forced to remain in the car while Hulton reiterated his plea that she become his wife. She finally had secured her freedom, she said, when she had promised to marry him.

Upon returning home at an early hour in the morning she called him on the telephone and told him that she would never live up to the promise, inasmuch as it had been obtained by force.

Last night as she was returning home, the love-crazed youth was

awaiting her in an automobile parked nearby. As she drew abreast of the machine he jumped out and grasped her roughly about the waist. In one hand he held a revolver and as the girl's struggles grew more violent he leveled the weapon at her head and fired, the bullet furrowing her scalp.

He then grasped the gun by the muzzle and beat her savagely about the head, felling her to the pavement.

Despite the stunning blows the girl struggled to her feet and ran toward the doorstep disregarding two more shots that were fired at her as she fled. Both bullets gouged out deep grooves in her scalp. The crazed suitor then jumped into the waiting car and speeded away.

The girl, in the meantime, staggered into her home and collapsed in the arms of her sisters, Sarah, 18, and Sylvia, 22. The young women carried her to the street where they hailed a passing car and took her to the hospital.

A phone call made to the Lemanoff home by Hulton later revealed his whereabouts to police. A policeman on the beat, having been notified, traced the call back to Chester and notified authorities there. His arrest followed. He had planned to flee immediately after the call, police say.
